



## **Universal Consent Form for Photography, Video, and Audio Recording**

### **Adistec Connect F1 Experience**

#### **1. Event and Purpose**

Adistec and its Media Partners will be capturing photographs, video recordings, and audio/voice recordings during the Adistec Connect F1 Experience Event. These recordings may include identifiable images, likenesses, and voices of participants. The purpose of this consent is to allow Adistec to use this content for public marketing, corporate communications, and event documentation.

#### **2. Types of Data Collected**

During the Event, Adistec and its authorized Sponsoring Vendors and Media Partners may collect:

- Photographs
- Video recordings
- Audio/voice recordings
- Combined audiovisual materials

These may include your face, voice, gestures, and other identifiable characteristics.

#### **3. How the Content Will Be Used**

If you consent, Adistec and its authorized Sponsoring Vendors and Media Partners may use your image, voice, and likeness for the following purposes:

- Public marketing and promotional materials.
- Publication on Adistec's public website.
- Publication on Adistec's official social media channels (including LinkedIn, Instagram, YouTube, X, and similar platforms)
- Press releases or media coverage.
- Internal communications, presentations, and archives.

Adistec will not sell your personal data.

#### **4. Risks of Public Dissemination**

By consenting to public use, you acknowledge that:

- Content posted online may be shared, reposted, downloaded, or screenshotted by third parties.
- Social media platforms may apply their own licensing terms to uploaded content.
- Adistec cannot fully control redistribution by third parties.
- If you withdraw consent later, Adistec will remove your content from its own channels, but complete removal from the internet cannot be guaranteed.

#### **5. Legal Basis and Voluntary Participation**

- Your consent is the legal basis for this processing.
- Your participation in the Event does not require you to consent to being photographed or recorded.

#### **6. Data Retention and Security**

Adistec will:

- Store recordings securely with restricted access.
- Retain raw footage for up to 5 years, unless required longer for legal or archival purposes.
- Retain published marketing materials for their natural lifecycle unless you withdraw consent.
- Require all external photographers and videographers to follow strict confidentiality and security obligations.

#### **7. International Transfers**

Your data may be stored or processed in countries outside your jurisdiction. Where required, Adistec will implement appropriate safeguards such as Standard Contractual Clauses or equivalent protections.

#### **8. Your Rights**

You may at any time:

- Withdraw your consent.
- Request removal of your image or voice from future materials.
- Request access to your personal data.
- Request correction or deletion of your data.
